**An Ordinance amending Chapter 11, Refuse Collection Service of the City of Mount Rainier Code of Ordinances.**

**WHEREAS**, the City of Mount Rainier established chapter 11, Refuse Collection Service for the purpose of setting regulations concerning refuse collection service in the City of Mount Rainier; and

**WHEREAS**, the Chapter 11, Refuse Collection Service of the *Mount Rainier Code of Ordinances (the Code)* contains conflicting or confusing language concerning services pertaining to yard waste and special bulk trash.

**NOW, THEREFORE, BE IT ORDAINED** this \_\_\_\_\_ day of \_\_\_\_\_, 2009 that Chapter 11, Refuse Collection Service of *the Code* is hereby amended as follows:

**Section 11-110. Yard Waste Collection**

3. must be placed in proper containers (e.g., a 33 gallon water tight container, paper bags, or a sturdy cardboard box) or tied securely with string or twine into compact bundles not more than four feet ( 4') in length and fifty (50) pounds. Wire must not be used to tie bundles of yard waste. ~~Plastic bags shall not be used to hold yard waste.~~

5.4. Yard waste in excess of the usual volume (i.e., three cubic yards) or in the form of private trees will be removed at a cost based on the City's cost per ton plus a reasonable amount for labor and equipment and administrative costs, with a fifty dollar (\$50) minimum charge.
