**CITY OF MOUNT RAINIER
RESOLUTION 32-2005**

(Drafted by City Manager and Mayor Miles)

Introduced by: Mayor Miles, and Council members Briones, Morton, Gandee, and Knedler.

A Resolution to establish a Youth Program and Recreational Committee.

WHEREAS, the Mayor and Council have the authority to establish volunteer committees to address matters of concern in the community; and

WHEREAS, there is no community center within the boundaries of the City of Mount Rainier to use by the older teenage population; and

WHEREAS, citizens have expressed an interest in serving on a youth committee that will address the lack of youth recreational programs in the City for adolescents and older teens; and

WHEREAS, there is a need for all recreational programs to be coordinated through one source, and the Youth Program and Recreational Committee would be given this responsibility.

NOW, THEREFORE, BE IT RESOLVED this 7th day of February, 2006 as follows:

1. The Mayor and Council hereby establish a City of Mount Rainier Youth Program and Recreation Committee.
2. Residents are appointed as members to this committee to serve two (2) year terms that will expire on the 1st day of June in each odd numbered year following their appointments.
3. The Youth Program and Recreational Committee will consist of seven members that represent the diversity of the community regardless of age, ethnicity, or sexual orientation.
4. The Youth Program and Recreational Committee is charged with the responsibility of identifying programs for all ages; evaluating and recommending proposals to the City Manager; working with Maryland-National Capital Park and Planning Commission; identifying funds and resources to bring or increase recreational activities in the City; and to keep the Mayor and Council abreast of its activities, operation, and project recommendations.

5. The Mayor and Council will allocate funds within its budget for implementing programs and recreational activities that are recommended by the Youth Program Committee and approved by the Mayor and Council.
6. The Youth Program and Recreational Committee will seek to include or be included with Maryland-National Capital Park and Planning Commission Recreation Council (Prince George's) planning activities via their recreation council or other similar recreational committee or body.
7. A member of the Mayor and Council will be appointed to serve on this and the Youth Program and Recreational Committee, but shall not have a vote in the Committees' decisions and/or recommendations to the Mayor and Council.
8. Meetings of the Youth Program and Recreational Committee shall follow the Open Meetings Law in all of its meetings and deliberations.
9. The Youth Program and Recreational Committee shall provide monthly reports to the Mayor and Council or as necessary to keep them informed of progress or obstacles that may require Mayor and Council input.
10. The Mayor and Council appropriate \$300 for the Youth Program and Recreation Committee to cover incidentals and other miscellaneous needs. All funds must be requested through the City Manager and approved prior to expenditure.
11. A youth representing each ward will be appointed to the committee with parental approval.
