**Awarding a Contract to Murphy & Murphy, CPA, LLC for Preparation of an Audit of the Fiscal Year 2013 Financial Records of the City of Mount Rainier.**

**WHEREAS**, the Mount Rainier Charter, Article VII, Finance, Section 709 and Annotated Code of Maryland, Article 19, Comptroller, Sections 37 and 40 require the preparation and filing of an annual audit report and comprehensive annual financial report of the books, accounts, records, and reports of the City for each fiscal year; and

**WHEREAS**, the City issued a Request for Bid Proposals (“RFP”) Financial Audit FY 2013 inviting sealed bid proposals from qualified firms of certified public accountants to audit the City’s financial statements for FY 2013.; and

**WHEREAS**, four proposals were received in response to the City’s RFP; and


**WHEREAS**, the Council and City staff have reviewed the proposals to audit the City’s financial records and to prepare the City’s Uniform Financial Report for FY 2013 and recommend that a contract for the FY 2013 audit and comprehensive annual financial report preparation be awarded to the accounting firm of Murphy & Murphy, CPA, LLC.


**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MOUNT RAINIER, MARYLAND**, that the proposal for financial audit services for FY 2013 received from the accounting firm of Murphy & Murphy, CPA, LLC is accepted with a cost of \$12,800.00 for an audit of the City’s financial statements and preparation of a Uniform Financial Report for FY 2013.




