**A Resolution Approving a Police Services Agreement
for Police Patrol Services in the Town of Brentwood between
the City of Mount Rainier and the Town of Brentwood.**

WHEREAS, the Town of Brentwood does not have its own police department and has relied upon Prince George=s County contract police services to protect its residents; and

WHEREAS, the Town of Brentwood desires to increase the police presence in the Town of Brentwood and to provide an improved level of police protection in the Town; and

WHEREAS, the Town of Brentwood has requested assistance from the City of Mount Rainier Police Department to provide police patrol services in the Town of Brentwood; and

WHEREAS, the Town of Brentwood has asked the City of Mount Rainier Police Department to make one Mount Rainier police officer available for full-time (*i.e.*, 40 hours per week) police patrol services in the Town of Brentwood; and

WHEREAS, the Town of Brentwood is willing to pay the costs of the Mount Rainier Police Department providing an officer for daily police patrol and related services in the Town of Brentwood; and

WHEREAS, Section 2-105 of the *Annotated Code of Maryland*, Criminal Procedure ' 2-105 (Athe mutual aid statute@) authorizes the governing body of a municipal corporation, such as the City of Mount Rainier, to enter into mutual aid and reciprocal enforcement agreements providing for police officers to lawfully go beyond the boundaries of the municipal corporation and exercise police powers in another jurisdiction; and

WHEREAS, in accordance with the requirements of the mutual aid statute, the City of Mount Rainier and the Town of Brentwood desire to enter into a mutual aid agreement establishing the terms and conditions for Mount Rainier police officers to exercise police powers in the Town of Brentwood; and

WHEREAS, the proposed Police Services Agreement (Police Patrol Services in the Town of Brentwood) is for a term of one year, beginning July 1, 2008, and ending June 30, 2009, and the Agreement can be renewed for subsequent one year terms by mutual agreement of the Councils of the City of Mount Rainier and the Town of Brentwood.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF MOUNT RAINIER that the Council approves a Police Services Agreement (Police Patrol Services in the Town of Brentwood) between the City of Mount Rainier and the Town of Brentwood, as set forth on Exhibit AA@ attached to this Resolution and made a part of this Resolution by reference, and authorizes the Mayor and the City Manager to sign and execute such Police Services Agreement with the Town of Brentwood.
